Production requirements for lightbox graphics include a professionally produced material called duratrans. The attached Las Vegas-based vendor list is provided for easy reference. However, event producers may use any production vendor of their choice, regardless if they are on the attached list or not, as long as appropriate duratran materials are utilized in the production of the graphics. It is the responsibility of the Lessee to work directly with a qualified printer for artwork submission, deadlines and payment of duratran graphics. The event producer is responsible for the payment of the standard 15% commission to the Las Vegas Convention Center for public area advertising as specified in their lease.

LVCVA Sign Shop staff will coordinate insertion and removal of the graphics into the lightboxes pre-andpost show. If graphics are to be returned to the event producer, please ensure specific instructions are provided. Standard practice will be to remove and discard all graphic materials after completion of show, unless otherwise instructed.
