

# **Satellite Symposium Application & Guidelines**

The Society of Hospital Medicine (SHM) is pleased to offer the opportunity to hold virtual satellite symposia during SHM Converge 2024, which will be held April 12-15, 2024.

SHM's annual conference is the premier event for healthcare professionals who specialize in hospital medicine. The target audience includes hospitalists, general internists, pediatricians, subspecialists, and family practitioners caring for hospitalized patients, whether in a community hospital or academic medical center. SHM has a maximum of four evening slots available for programming.

# **Criteria for Application**

If you would like to be considered for a satellite symposium program, you will need to complete the enclosed "Request for Satellite Symposium" application and attach a complete description of the symposium including:

- a. Program Title
- b. Program Description
- c. Target Audience
- d. Learning Objectives
- e. Proposed Program/Agenda
- f. Names, affiliations, and contact information of proposed faculty. (We request that at least one hospitalist be included on the faculty.) SHM Board members and SHM Converge faculty are not eligible to serve as symposium faculty. Please reach out to SHM staff to make sure your speakers are not currently faculty for SHM Converge 2024. Current SHM Board members are listed here.
- g. Name of sponsoring organization/company providing the educational grant. Funding must be approved before submission.

### Applications are preferred by March 8, 2024.

SHM requires that all satellite symposia be CME certified or non-CME and presented in an objective, scientifically rigorous, and balanced manner. The symposium cannot promote a specific drug product, or any devices. In addition, the proposed objectives should clearly meet the educational needs of SHM members and the target audience.

Space for satellite symposia is limited. SHM will only consider complete applications.

#### **Review Process**

Satellite symposia requests will be reviewed by representatives of SHM's Annual Conference Committee. Acceptance will be based on topic and scientific content and notification will be provided in writing within seven days of receiving complete application.

If accepted, every effort will be made to honor the applicant's first choice of time slots (see Live Symposia and Fee Schedule). If the assigned time slot is not acceptable, the applicant has the option of withdrawing the application within one week of the notification.

Please Note: A satellite symposium program may not be held during an SHM Converge 2024 educational event. In addition, any faculty member participating in SHM Converge 2024 may not participate in a satellite symposium as faculty.

The symposium cannot promote a specific drug product, or any devices. In addition, the proposed objectives should clearly meet the educational needs of SHM members and the target audience. As with Satellite Symposia, all content is subject to SHM Annual Conference Committee approval.
