



HIMSS21 Conference Layout








Hosting a special event? Let HIMSS help!

Note:

- Booth selection appointment times are scheduled in exhibitor priority point order.
- Points for booth selection will be calculated as of December 31, 2019.



Top 250 Booth Selection Appointments

- If you are selecting in the top 250, emails will be sent out the week of January 20 with appointment times and webex information
- Appointments times are ordered based on HIMSS priority points as of December 2019
- All Top 250 appointments are **CENTRAL TIME**
- All companies receive the same WebEx information so we ask that you call in during your appointment timeframe only
- Please be prepared to sign the booth space contract (online) and pay the booth deposit immediately following your selection time. Both steps MUST be completed or booth space WILL be released on the last day of the onsite booth selection, Thursday, March 12, 2020.
- Please be on time and stick to the schedule, as we have back to back appointments scheduled for the entire day if a booth is not decided during the scheduled meeting, HIMSS will have to move onto the next person

Onsite Booth Selection Appointments

- Appointments times are ordered based on HIMSS priority points as of December 31, 2019
- Booth Selection will take place in room 101B, Level 1, of the Orange County Convention Center
- Please look for signage directing you to the room or visit any of our information desks for assistance
- Please show up to appointment 5-10 minutes early to view the floor plan before selecting your space
- Please be prepared to sign the booth space contract (online) and pay the booth deposit.
 <u>Check or credit card payments accepted.</u>
- Both steps MUST be completed or booth space WILL be released on the <u>last day of booth</u> <u>selection, Thursday, March 12</u>
- Once you arrive to the room, there will be instructions on where to go next

What if I can't make my appointment?

- If your appointment is in the top 250, please work with your HIMSS sales manager to schedule a time to select your space prior to HIMSS20 or you can come to the booth selection room onsite during booth selection hours
- If your appointment is onsite and you cannot make it, feel free to come by the room, anytime after your scheduled appointment, during booth selection hours
- If you can't attend HIMSS21 onsite booth selection, you can select your space beginning <u>Monday, March 16</u>, with your HIMSS sales manager



General Rules of the Show

- In order to maximize exhibit space in Las Vegas, we will be using a set floor plan
- You may only choose existing booths that are on the floor plan
- Any alterations of existing booths on the show floor will not be allowed for HIMSS21
- You may increase your booth size from HIMSS20
- If booth is along the center aisle the 70% rule applies. Example: sq ft along the aisle, there has to be a minimum of 70% depth.



Logistics Information

- Hall A-D ceiling height is 32 feet and the maximum height for your booth or hanging sign is 24'
- Venetian Ballroom ceiling height is 22-28 feet and maximum height for hanging signs or structure is 16'. Ballroom has limited rig points.
- Caesars Forum ceiling height is 22-24 feet and maximum height for hanging signs or structure is 16'. Ballroom has limited rig points.
- Columns can be wrapped if in booth, but need to leave specialty accessories (fire extinguisher medical equipment etc.) exposed.
- Columns range from 2 3.5 feet in diameter
- All electrical/networking will be pulled from ceiling

HIMSS21 Booth Wait List

- Must have a booth at HIMSS21 to be added to the wait list
- Booths on the wait list are for 20'x20' and larger (no 10'x10' or 10'x20' booths)
- Booth moves are done based on priority points
- You will be removed from the booth wait list after one successful move
- Wait list will end <u>September 4, 2020</u>
- Exhibitor is responsible for the price difference with a booth move

HIMSS21 Sponsorships
