

Request for Information from the Office of Management and Budget (OMB) – Comments Submitted July 6,2021

- Joint letter between HIMSS and Personal Connected Health Alliance
- High level comments consisted of the following thoughts and recommendations:
  - Government Agencies are Making Great Strides to Achieve Goals Concerning Equity
    - Centers for Medicare & Medicaid Services (CMS) Path to Equity
    - Office of the National Coordinator for Health Information Technology (ONC) Health IT Demographic Electronic Health Record (EHR) Certification Requirements
    - Department of Health and Human Services (HHS) Office of the Chief Technology Officer -<u>The State of Data Sharing at the U.S. Department of Health and Human Services</u>

Request for Information – Comments Submitted July 6,2021

- More Opportunities for the Federal Government to Lead
  - Conversation must expand to think about questions such as:
    - Are programs communicated such that all levels of education can comprehend the inquiry and engagement?
    - Are notices for programs and policies available in multiple languages?
    - Is there a means to consolidate various resources related to existing assistance programs and policies so that recipients are not left questioning which one serves them best?
- The Importance of Access to Quality Reliable Broadband in All Advancing Equity Discussions
  - Need and Role Remote Patient Monitoring (RPM) Can Play
- HIMSS Actions to Heighten the Focus on Health Equity
  - HIMSS GHEN launched in early 2020



# Update of An Introductory Resource Guide for Implementing the Health Insurance Portability and Accountability Act (HIPAA) Security Rule

Comments accepted until July, 9, 2021- Draft approval currently pending

- HIMSS strongly supports the National Institute of Standards and Technology's (NIST's)
  decision to update the Resource Guide to include improvements to the guide as well
  as increase awareness, applications, and uses for it. The twelve-plus years that have
  occurred since <a href="#special-80-66">SP-800-66</a>, <a href="Revision 1">Revision 1</a>
- Recommendations included:
  - Updates to the Resource Guide Must Reflect References and Implications to Current Regulations Including But Not Limited to the HITECH Act and The HIPAA Omnibus Rule



# Update of An Introductory Resource Guide for Implementing the Health Insurance Portability and Accountability Act (HIPAA) Security Rule

Comments accepted until July, 9, 2021- Draft approval currently pending

- The updates to the resource guide should include specific existing NIST references and federal resources
- Recent federal guidance relative to ransomware and threats, particularly from the Federal Bureau of Investigation (FBI), OCR, and the Department of Homeland Security (DHS)
   Cybersecurity and Infrastructure Security Agency (CISA), should also be included in Revision
- Amplify Overall Awareness of this Resource to Encourage Stakeholder Engagement, Use, and Understanding of the Significance of the Updates



## 21st Century Cures 2.0 Act Discussion Draft

- Representatives DeGette (D-CO) and Upton (R-MI) release long-awaited Cures 2.0 discussion draft, a follow-up to the 21st Century Cures Act that was signed into law in 2016.
- Discussion draft is broken into five titles:
  - Title I: Public Health
    - Key Provisions: Study on long-term impact of COVID-19 and efforts to prepare for future pandemics
  - Title II: Patients and Caregivers
    - Key Provisions: Caregiver education and training, health literacy programs, diversity in clinical trials
  - Title III: FDA
    - Key Provisions: Collaboration and Alignment in Regulating Digital Health Technologies, Increasing Use of Real-World Evidence,
  - Title IV: CMS
    - Key Provisions: Expands Medicare Telehealth, Telehealth under CHIP and Medicaid, Medicare Coverage and Payment for Breakthrough Devices, and reports on innovative health technologies
  - Title V: Research
    - Key Provision: Creates the Advanced Research Project for Health (ARPA-H), a priority for the Biden Administration
- Comments on the discussion draft are due July 16, but path forward remains uncertain



### Patient Matching and Identification Legislative Efforts

- Section 510 of the Labor-HHS Appropriations bill contains a ban on any federal funding used
  to promulgate or adopt a unique patient identifier. This has been interpreted over the years
  in a way that hasn't allowed HHS to actively engage with the private sector on patient
  matching efforts.
- The last two years, the House has voted to remove Section 510 from the LHHS Appropriations bill, but the Senate has ultimately kept it in the final version.
- COVID-19 has exacerbated the issue and emphatically highlighted the need for a national strategy with HHS as a key partner. Momentum on Capitol Hill is shifting and we remain optimistic that this will be the year the ban will be removed
- As Congress begins the annual appropriations cycle, HIMSS and the broader healthcare community will need all the support from our members to convince Congress to remove the ban and focus on addressing patient matching challenges across the country!




### State, Local, and Provincial Government Representation\*
