

HIMSS23 Booth Selection Timeline

Important Dates		
January 10-24, 2022	Anchor Selection	
February 7-25, 2022	Top 250 companies select virtually before HIMSS22	
March 14-17, 2022	Onsite Booth Selection at the Orange County Convention Center New this year, we will be located on the show floor! Booth 6687, Hall D (behind the Federal Health Pavilion) *Both onsite and virtual appointment options will be available	

Note:

- Booth selection appointment times are scheduled in exhibitor priority point order.
- Booth selection order is based on points as of December 31, 2021.

You are allowed to secure a <u>booth size of your choice</u> within HIMSS exhibitor rules and regulations. The HIMSS Sales Team will work with you to configure a desirable available location and size.



Top 250 Booth Selection Appointments

- If you are selecting in the top 250, emails will be sent the week of January 31, 2022, with appointment times and
 Zoom information
- Appointments times are ordered based on HIMSS priority points as of December 31, 2021
- All Top 250 appointments are <u>CENTRAL TIME</u>
- All companies receive the same Zoom appointment link (Zoom will run all day) so we ask you to call in during your appointment timeframe only
- Exhibitors will be required to sign the booth space contract (online) and pay the booth deposit immediately
 following your selection time. Both steps <u>MUST</u> be completed or booth space <u>WILL</u> be released on the last day of
 the onsite booth selection, <u>Thursday</u>, <u>March 17</u>, 2022.
- Please be on time and stick to the schedule as we have back to back appointments scheduled for the entire day. If you do not select a booth during the scheduled meeting, HIMSS will move onto the next person.

Onsite Booth Selection Appointments

- Appointments times will be sent out the week of February 7
- Appointment times are Eastern Time Zone since we will be in Orlando
- Booth Selection will take place at the Orange County Convention Center Booth 6687, Hall D, behind Federal Health Pavilion
- Please look for signage directing you to the room or visit any of our information desks for assistance
- Please show up to appointment 5-10 minutes early to view the floor plan before selecting your space
- Please be prepared to sign the booth space contract (online) and pay the booth deposit. <u>Check or credit</u> <u>card payments accepted.</u>
- Both steps MUST be completed or booth space WILL be released on the <u>last day of booth selection</u>,
 Thursday, March 17, 2022.
- Once you arrive to the room, there will be instructions on where to go next

 - Please work with your HIMSS sales manager to schedule a time to select your space prior to HIMSS22


OR

HIMSS23 Booth Selection Opportunities

The following are available to select during your HIMSS23 Booth Selection Appointment:

- Standard Booth Space Zone 1 and Premium Zone
 - Space begins at 10'x10'
 - (5) badges per 10'x10' booth
 - Listing in HIMSS printed onsite guide, website, mobile app
- Meeting Place Rooms 10'x20' and 20'x20' options
 - Meeting room structure with ceiling, carpet and locking door
 - Conference table and 8 boardroom style chairs or lounge seating
 - 42" monitor, Electrical, Internet line (shared T1 line)
 - Cleaning
 - Exhibitor/Client Badges 10 (you determine the mix)
 - Priority Points 5 (9 points for 20'x20' option)
- Vendor Headquarters 10'x20'
 - Must have an exhibit space to purchase
 - Meeting room structure with locking door does not include ceiling
 - Carpeted floors
 - Priority Points 2

- Remaining deposit schedule
 - June 3, 2022: Remaining balance: 50% due
 - September 2, 2022: Remaining balance: 100% due


HIMSS23 Floor Plan




HIMSS23 Conference Layout

General Rules of the Show

- Can secure a booth size of your choice within HIMSS exhibitor rules and regulations. The
 HIMSS sales team will work with you on configuring your desirable available location and
 size. There are a few islands preset on floorplan, in order to maximize space.
- If booth is along a 20' aisle the 70% rule applies. Example: sq ft along the aisle, there
 must be a minimum of 70% depth.
- If there is a column beside your booth, your booth layout needs to accommodate the column doors being open 42", only in an emergency.
- If a column is located within your booth, you may use a sticker like material on the column (except on the side that contains a fire hose cabinet), but the doors must be accessible in an emergency. Cannot place a hard structure around the column, even if you leave access doors.




Logistics Information


- Hall Height is 40' feet from floor to ceiling. The maximum height for a sign or structure within booth is 24 feet.
- Columns in South Hall are approximately 10 x 10. There are four different columns types within the South Hall. See next slide for details on each column.
- Columns in North Hall are approximately 17 x 12. These columns are not located in any booth.
- HIMSS has placed additional 20' aisles and 10' aisles from front to back throughout the hall for easier navigation for attendees.
- South Hall contains two large floor to ceiling food concession areas (that are very busy during the show). These are highlighted on the floorplan.
- Meeting Place rooms will be located in both the South and North Halls.





South Hall Column information

South Hall Column details













North Hall Column information

HIMSS23 Booth Wait List

- Must have a booth at HIMSS23 to be added to the wait list
- Booths of 20 x 20 or larger can be placed on the wait list.
 (10'x10' or 10'x20' booths can not be placed on the wait list but continue to monitor the live floor plan and if you see an open location contact your sales representative)
- Booth moves are done based on priority points as of December 31, 2021
- You will be removed from the booth wait list after one successful move
- Wait list will end November 1, 2022
- Exhibitor is responsible for the price difference with a booth move

HIMSS23 Sponsorships

- Sponsorship renewal discussions can begin during booth selection; connect with your sales manager.
- If you contracted a sponsorship for HIMSS22, designated (*not all*) sponsorships will be eligible for <u>first rights of refusal</u> for HIMSS23.
 - -First rights of refusal will launch mid-June 2022 and must be contracted by August 1, 2022.
 - -Your HIMSS Sales Manager will reach out with additional information when/if available.
- August 1, 2022 is the target date to open all HIMSS23 sponsorship sales except those reserved for first rights of refusal.


