- What else? Showcases also feature networking, exhibit and thought leadership opportunities.






Attendee Worksite Breakdown






Attendee C-Suite Breakdown








Exhibit and Meeting Space

Connected Demonstrations



Demonstrations: What and Why

A demonstration organizes solutions within a clinical and technical context, allowing visitors to engage with an individual – such as a caregiver, patient or clinician – and their interoperability story while witnessing the immediate impact on clinical outcomes, quality and the overall patient experience.

- Up to ten (10) participating organizations collaborate to demonstrate a single story focused on an individual.
- All participants use interoperability and health standards to ensure they're able to demonstrate real-world data exchange.
- Participants work with HIMSS staff and other organizations to **develop unique storylines** that explore the value of their interoperability solutions.
- Each organization brings its own perspective and story to share, ensuring each demonstration is one-of-a-kind.
- Bring your interoperability solution, we provide the rest.



Demonstration Topic Development

The HIMSS Interoperability Showcase Team solicits and gathers demonstration topics via survey from the health information and technology community-at-large.

Key considerations:

- The earlier you participate in the Showcase the greater impact your organization has on the development of a demonstration, resulting in a more meaningful experience.
- Choice of demonstration topics are available on a first come first serve basis.
- Not sure where you belong? Our Lead Technical Project Manager can assist you to **find the most appropriate placement** for you in one of our demonstrations.

Minimum Demonstration Participation Requirements

- All participants must use an interoperability standard to exchange information (such as an HL7 Profile, IHE Profile, DICOM, DIRECT, etc.) and must undergo some proof of validation of associated standards to be approved by the Technical Project Manager.
- Proof of validation can be attestation, visual, or conformance/validation testing (such as participation and validation at an IHE Connectathon, a FHIR Connectathon, etc.). This process may be completed during the HIMSS Interoperability Showcase Workshop at the North American CAT23 in February. No proprietary exchanges will be allowed in the demonstrations.
- All HIMSS23 Showcase participants are required to participate in a HIMSS Interoperability Showcase
 Workshop during one of the IHE North American Connectathons to connect and collaborate with other
 testing partners around demonstration topics. Visit iheusa.org for more information.
 - o This event will be in-person for Connectathon testing participants and virtual for all others.
- Mandatory participation by technical staff in a weekly virtual meeting to plan your demonstration starting in December 2022.
- Mandatory attendance by demonstration staff at onsite set up for **one (1) day prior** to HIMSS23 (8:00 am-5:00 pm) AND during all exhibition hours.



Timeline

- September 6, 2022: Demonstration topics posted online & sign-up for <u>all</u> participants begins.
- 1st week of December: Weekly demonstration meetings commence with participant technical representatives and HIMSS Lead and demo-specific Technical Project Managers. Meetings continue until conference.
- January 15, 2023: Deadline to commit with signed contract for inclusion in the printed show guide.
- April 17, 2023: Mandatory full-day (8:00 am 5:00 pm) setup and rehearsal time onsite in Chicago.
- **April 18 20:** Mandatory demonstration participation during exhibit floor hours scheduled at alternating :15 and :45-minute slots each hour.




- Share this presentation with colleagues and business partners for strategy and approach planning.
